

NOTE: this Privacy Policy relates to individual CISV volunteers and employees, who register with us to give, receive or otherwise participate in a "CISV International Event", be it a Regional Training Forum, Regional Meeting, an International Junior Branch Event, a Global Conference or any other approved International meeting.

PART 1: INTRODUCTION

Thank you for reading our Privacy Policy. In it, we explain how we collect, use, and share the Personal Information that you share with us.

By "Personal Information" we mean personal data as defined in the UK [Data Protection Act 1998](#) (DPA), and from 25 May 2018, as defined in the [General Data Protection Regulation](#) (GDPR). In general, it means any information relating to you, which identifies you or allows you to be identified. That may be your name, an ID number, location, an online identifier or factors specific to you (e.g. physical, physiology (thoughts, feelings), genetic, mental, economic, cultural or social factors).

This Privacy Policy has four parts:

1. This introduction
2. Important information about your rights in relation to consent and to object to our use of your Personal Information
3. Key information required by the GDPR
4. Information about our registration platform provider, Certain, Inc.

PART 2: IMPORTANT!

Your rights in relation to consent: if you are in the European Economic Area, we ask you to consent to the transfer of your Personal Information to Certain, Inc.'s registration platform in the USA. This consent is only necessary to the extent (if any) that Certain, Inc.'s Privacy Shield certification does not cover the transfer. You may withdraw your consent at any time. However if you do so, we may not be able to register you on or provide you with the CISV International Event.

You may voluntarily provide us with sensitive Personal Information (such as information about your health or personal/special needs so that we can make adjustments). You may, at any time, withdraw your explicit consent to us using that sensitive Personal Information. However, please be aware that, without this information, we will not be able to make adjustments to provide for your needs.

("Certain")) is hosted in the US and your Personal Information will therefore be transferred to Certain's US-based data centres. Certain has joined the EU-US Privacy Shield, which has an adequacy decision from the European Commission: please see https://www.privacyshield.gov/welcome. We will transfer your Personal Information to CISV National Associations and Chapters that are outside the European Economic Area to the extent necessary to administer your registration and participation in the CISV International Event. For example if you live in Belgium but are travelling to Australia, the Belgian and Australian National Associations may be involved, as well as the Chapters nearest to where you live and to the CISV International Event. The basis for those transfers is that they are necessary for contract purposes, namely:</p> <ul style="list-style-type: none"> the performance of a contract between you and us, or the implementation of pre-contractual measures taken at your request, or are necessary for the conclusion or performance of a contract concluded in your interests between us and another person. <p>Please note that the absence of an adequacy decision and appropriate safeguards creates possible risks that you will not have the same rights and remedies in respect of the processing of your Personal Information once it is the US or other non-EEA countries as you would have in the EEA.</p> <p>Further information</p> <p>Here is a short explanation of the options for transferring Personal Information outside the EEA.</p> <p>First, an "adequacy decision" which is a legal decision by the European Commission that adequate protection is provided by a country, territory, specified sector(s) or an international organisation.</p>
